LICENSE AGREEMENT

on the transfer of rights to use copyright works submitted for participation in the creative Contest "Golden Turtle"

- 1. Terms and their definitions used in this Agreement:
- 1.1. The "Golden Turtle" Creative Contest (hereinafter referred to as the "Contest") Contest of authors in the field of photography, art and design.
- 1.2. The "Golden Turtle" Festival an educational and entertaining event, held after the completion of the Contest by the Contest Organizer, as well as other specialized events dedicated to the popularization of the Contest and Festival, including partner events.
- 1.3. The copyright holder of the Contest is the copyright holder of the trademark of the creative Contest "Golden Turtle", exhibitions and all objects and events associated with this name the Charitable Foundation for Social Support "MY EQUATOR" (Certificate of Registration (OGRN) 1167700073056 dated 11.11.2016).
- 1.4. The organizer of the Contest is the organizer of the creative Contest "Golden Turtle", exhibitions and all objects and events associated with this name the Charitable Foundation for Social Support "MY EQUATOR" (OGRN 1167700073056).
 - 1.5. Contest Rules the Contest rules published on the Contest website www.wncontest.ru/en.
 - 1.6. Participant is the author who submitted his work to participate in the Contest.
- 1.7. Work a creative work (photography, object of painting and design) submitted for participation in the Contest
 - 1.8. Agreement license agreement (license).
- 2. By uploading his creative works to his personal account on the Contest website for participation in the Contest, the Participant, free of charge, under the terms of a license, grants the Contest Organizer the right to use the Work in the ways indicated below:
 - 2.1. to submit the Works in printed or digital form (on any storagy) for evaluation by the Contest Jury;
 - 2.2. to use the Work in any way for the purpose of promoting the Festival and Contest;
- 2.3. to post the Work in any section of the websites, under the "Golden Turtle" brand, in official groups on the Organizer's social networks and partner social networks; submit the Work to newspapers and magazines for the purpose of covering the Contest and Festival in the news;
- 2.4. to use the Work to inform the public about the Contest and its results, as well as for the purpose of advertising the Festival and the Contest, announcing the Festival and the Contest, including in printed materials, on the Internet, on television, in electronic form, street advertising, tickets, as well as by any other methods not prohibited by the legislation of the Russian Federation;
- 2.5. to use the Work to decorate the space (venue) of the Festival, including the press area, exhibition area, entrance area, photo area, stage, etc;
- 2.6. to use the Work for external events (traveling exhibitions, festivals, presentations, lectures, press conferences, charity evenings, etc.) both in Russia and abroad;
 - 2.7. to use Work on plastic cards, for screensavers of electronic devices, applications and programs.
 - 2.8. to use for the development and production of branded products;
- 2.9. to publicly perform the Work, that is, present it live using technical means (television and other technical means);
- 2.10. to reproduce the Work, that is, make copies of the Work or its part (without limitation on the number of copies) in any material form, in particular, reproduce the Work or its part in a typographical

(printed) way, including, but not limited to, for printing in books, photo albums, magazines, booklets, in the form of calendars, postcards, promotional materials, posters, placards, prints, souvenirs and other printed materials; produce any souvenir materials using the Work, as well as alienate such products;

- 2.11. to process the Work;
- 2.12. to use the Work for marketing purposes and searching for sponsors;
- 2.13. to transfer the above rights to third parties (sublicense).
- 3. Copyright to the Work remains with the Participant. The Participant has the right to independently dispose of the Work, incl. transfer copyright to third parties.
- 4. The Organizer of the Contest undertakes to indicate the name of the Participant when using his/her Work in any form and the Contest logo in order to comply with the Legislation of the Russian Federation regarding copyright.
 - 5. The Organizer is not obliged to provide reports on the use of the Works to the Participant.
- 6. Funds received from the use of the Works under the terms of this Agreement will be directed to charitable purposes consistent with the statutory goals of the Organizer's activities (including promoting activities in the field of education, science, culture, art, enlightenment, spiritual development of the individual; expanding the scope of environmental education for young people generation; promoting an ecological lifestyle on a Russian and international scale, working on environmental education, culture and education; promoting the protection of motherhood, childhood and paternity; providing material and other assistance to children with various types of diseases; promoting the strengthening of the prestige and role of the family in society, etc. .), minus the costs associated with the organization and conduct of the Contest, Festival and all related events.
 - 7. The Participant guarantees that:
 - 7.1. he is the legal copyright holder of the Work;
- 7.2. at the time of entry into force of this Agreement, the Participant is not aware of the rights of third parties that may be violated by granting a license for the Work under this Agreement;
- 7.3. at the time of concluding this Agreement, the exclusive right to the Works has not been alienated, pledged, or granted under license agreements to other persons;
- 7.4. at the time of concluding this Agreement, the Participant's rights to the Work have not been challenged in court or in any other legal way.
- 8. The validity period of this Agreement is the duration of the Participant's exclusive right to the Work. The License is issued for the entire duration of the exclusive right to the Work. The agreement is valid throughout the world. According to the Agreement, the use of the Work by the Organizer is allowed without restrictions on the territory.
- 9. During the period of validity of this Agreement, the Participant is obliged to refrain from any actions that could impede the implementation by the Organizer of the right granted to him to use the Works within the limits established by the Agreement.
- 10. The Participant is aware and agrees that the Contest Organizer does not pay him any remuneration for transferring a license to use the Work.
- 11. This agreement is an offer. The Author agrees to the terms of the offer by uploading the Work to the Contest website. The parties consciously came to an agreement and confirm the electronic format of signing this agreement, due to the impossibility of signing on paper. The parties acknowledge the legal force of the electronic copy of the Agreement.
 - 12. This Agreement is governed by the laws of the Russian Federation.
